Early Childhood Education will be coordinated between the district Early Childhood special education program, the PAT program, the district Title One preschools, and the local community preschool. These programs will support each other through communication, funding, and providing appropriate services. Since leaving the early childhood special education cooperative, we have further integrated these programs/services.

Kindergarten screenings; which involve the PAT coordinator, kindergarten teachers, special services personnel, and the elementary principal; assist with this transition. Parent events also help with this transition.

The Missouri Comprehensive Guidance program is followed, which includes the creation of a 4 year plan at junior high level. Students also complete a career unit with the secondary counselor, which takes around 3 days to complete.

Not applicable; the LEA is a K-8.

Describe transition strategies to facilitate effective transitions for students from high school to post-secondary education:

Vocational education, dual credit courses, and career courses all factor into this area. The Missouri Connections program is utilized, which assists in establishing what has to be completed (prerequisites) to pursue a specific career. The counselor stresses goals that leads to courses to take. Then, with the help of a little research, a plan can be formulated.

If applicable, describe those strategies that are coordinated with institutions of higher education, employers, and other local partners:

There is a Job Fair in West Plains, MO. There is a college fair in Houston, MO. Every other year, the high school counselor initiates a career day, at which time people from various industries come to Summersville to share experiences, and answer questions about requirements, expectations, education, etc. Job shadowing is another option for some students. Special education students are assisted in the transition to work with the help of the Vocational Rehabilitation Coordinator.

If applicable, describe those strategies that increase student access to early college high school or dual or concurrent enrollment opportunities or career counseling to identify

Dual credit courses are offered at Summersville, and college/university representatives present to students about programs offered, prerequisites, etc.

The Missouri Model Evaluation System is implemented, which evaluates teachers at 4 levels: emerging, developing, proficient, and distinguished. This is described in detail on screen 18a of core data. All efforts are made to utilize evaluations to improve instruction and weed out mediocrity. In a small school there are a smaller number of teachers for students to be exposed to.

Summersville R-2 School District makes every effort to assign staff members to appropriate teaching assignments. Most of the teaching staff is experienced. When a new teacher arrives, they receive a great deal of mentoring and advice from various sources.
